BOUZAID 62 BLUEWATER CRUISER


Designed in conjunction with Chris Bouzaid and the Waianiwa Group in the USA, the brief was for a fast, safe, comfortable ocean-going cruising yacht, with a classic but modern style in her aesthetics. Our intent has been to provide a boat readily sailed shorthanded handed and with a turn of performance that will allow her crew exhilarating sailing within a moderate displacement. This boat is ideally suited to participation in any of the various ocean cruising rallies that are currently enjoying increasing popularity.

The hull is designed with a fine 'V' shaped entry, a moderate beam and a well-balanced hull volume distribution allowing good load carrying capacity without affecting the performance characteristics of this very comfortable design.

The raised upper saloon and Navigation station allows guests and owners to enjoy the views and sightlines while under sail or when in port; with formal saloon and entertaining further below. Two main sleeping Cabins with a third for extra guests and a well laid out galley ensure all the comforts are catered for.

The cockpit is laid out for shorthanded sailing with very comfortable lounge type seating for crew or guests. Further seating and or lounging are catered for either side of the companionway.

In summary, this design will cater for those looking for a performance orientated, safe, long distance cruiser with a layout that caters for both entertaining and sailing comfort.

CEProof 'Dibley Marine' & 'CE proof NZ'

Dibley Marine works closely with CE proof NZ to ensure it's design, structures and equipment fit out are fully compatible with the European Union's Recreational Craft Directive (RCD 94/25/EC). Vessels from Dibley Marine are able to be traded in member states of the European Union without any further survey or approval requirements, when the vessel lands in Europe.

"It's a one-stop shop with CE proof NZ" says Dibley. "We work closely with Rolf Eidt and Neil Spencer from CE proof NZ from the early design stages to the fixing of the Builder Plate and it's a no-fuss system". Their involvement allows us to concentrate on design refinement without having to worry about the EU compliance paper work." Compliance costs are minimised and we have control over the certification process as all the work is undertaken here in New Zealand.

CE proof NZ is part of the CE proof world-wide network. With the Head Office in England, CE proof NZ has overnight access to any changes in the CE statutory requirements for recreational craft. Compliance submissions are prepared in New Zealand and submitted for approval through the CE proof network to the European Notified Bodies. It is the Notified Body that has delegated Authority from the EU in Brussels, to approve submissions. CE Approval is mandatory for all recreational craft for sale or before being put into service, within the EU member states. The partnering arrangement between Dibley Marine and CE proof NZ allows Dibley Marine immediate access to the current requirements of the RCD and the institutionalised peculiarities of marketing vessels in the European Union.

The interesting part of the CE proof network is their expansion into the US market where a plethora of regulations apply to the construction of non-commercial watercraft. CE Proof NZ provides Dibley Marine with advice and guidance on the most effective method of seeking USCG, CFR, ABYC and NMMA compliance within the USA.
